



sequent to the Supreme Court Judgment, the Model Constitution of Governing Body issued by AICTE in its approval Regulations 1994, stands overruled. It has been held that while AICTE will not insist on any nomination in the Governing Body of the Unaided Institution, the Affiliating University/ State Government shall impose minimum conditions of affiliation, such as prescription of qualifications of Governing Members, in order to insure academic excellence.
